Each year, Fruitland Mutual Water Co. members elect several Board of Directors from a slate of candidates. The nominees may be new or existing Board Members seeking re-election. If you would like to serve on the board of Fruitland Mutual Water Co., or have a candidate to nominate, please send the candidate's name to our office.

Eligible candidates must be members of the Fruitland Mutual Water Co. in order to qualify for consideration. Prior to submitting a nomination, it is required for the candidate's permission to be granted, along with the signature of two additional Fruitland members for validation. Please include a brief biography and qualifications of the nominee. For the preparation of the ballot, please submit your nominations as early as possible. Proposals for bylaw changes can be received for review by the Board of Directors. Proposed changes must be accompanied by signatures of at least two members. All nominations and proposals must be received at the company office (4001 9th St SW) no later than 4:30pm on January 7, 2025.

REMEMBER TO WINTERIZE:

As the chilly winter months approach, it is essential to protect your plumbing system from freezing temperatures. To prevent costly repairs, consider these simple steps: insulate exposed pipes, let faucets drip a little during extreme cold, disconnect hoses from outdoor spigots, and maintain your home's temperature at a steady level, ideally around 55°F or higher, to prevent pipes from freezing. By taking these precautions, you can help ensure your plumbing system remains frost-free and trouble-free throughout the winter season.

A WORD FROM OUR GENERAL MANAGER:

Dear Members,

Fruitland Mutual Water is updating their Hazard Mitigation Plan for the 2025-2030 cycle. This update was approved by the Fruitland Mutual Water board of directors at the August 19th Board meeting. FMWC is working in conjunction with the Pierce County Emergency management as well as other utilities in the region on this update. Please go to our website if you would like to see the approved minutes from the board meeting. Please take the survey we have added to our website from Pierce County. You can download or print off the survey and then forward any concerns on to us. This survey will help you understand and see how prepared you might be, and the feedback helps us, and the county plan any additional emergency preparedness that may be needed.

Our next annual meeting will be held on February 20th, 2025, you are welcome to come if you have questions or concerns about the Hazard Mitigation update.

It's a good idea to always have water storage on hand in case of any emergency that might arise that can affect your water service. The average American uses between 80-100 gallons of water a day, this includes water used for drinking, cooking, bathing, washing dishes and clothes, flushing toilets and other outdoor activities.

Later this fall and during winter the Fruitland crew will be working on annual maintenance. Part of this is trimming around fire hydrants and meter boxes. If you have special foliage or prefer to handle it yourself let us know so we can take note. The fire department requires a minimum of 3 feet of clearance all the way around fire hydrants. These requirements are the same for our water meters. Thanks for your understanding.
